Direct Support Professionals Need Our Support

Without the dedicated and committed army of Direct Support Professionals who come to work every day there would be no community services for people with disabilities. For too long our DSP's have worked without meaningful wage increases despite the hard work of numerous advocates who, over the past two years, have been able to obtain a %3 increase in 2018 and a small bonus in 2017. As advocates we know this is not enough, and we also know that our DSP's are not minimum wage workers. While we are in favor of a minimum wage increase, our message to the legislature is that the work our staff do is not minimum wage work. Any increase in wages through out the state must factor in an additional increase to ensure that DSP's are adequately compensated for the skilled work they do.

The Governor is working on the budget for the next fiscal year now, and so it is critical for him to hear from you about the impact of services and Direct Support professionals in your life.
